### DR. CLIFTON J. KENON, JR. | CLASS OF 2009

Dr. Kenon holds a Bachelor of Science in Nursing from WSSU; Master of Science in Nursing from the University of North Carolina at Charlotte; and a Doctorate in Nursing from Chatham University of Pittsburgh. He furthered his education with a post-doctoral study at the University of Tennessee with an emphasis on hermeneutic phenomenology.

He is senior health scientist and reproductive health advisor at the United States Agency for International Development in the Office of Reproductive Health and an adjunct professor in WSSU's nursing faculty. At USAID, Clifton is Senior Advisor on the Maternal Child Survival Program, The Flagship United States Foreign Aid, a \$500 million program that alleviates disparities related to maternal child survival in developing countries.

His domestic and international research efforts explore reproductive health, education, and racism. His research and expertise areas are in breastfeeding, family planning, health care policy and education.

In three years, Dr. Kenon was awarded five national awards for his outstanding leadership in shaping healthcare, and utilizing evidence, and innovation to improve the lives of American Indians and Alaska Natives. This is a federal record that is still held by him. He has been honored with numerous regional and national accolades, including the Woodville Award of which he was the youngest to ever receive it. He spoke at the White House on the importance of breastfeeding and childhood obesity after accepting an invitation from Former First Lady Michelle Obama.

In addition to being the first African American to hold an international director seat for the International Board of Lactation Consultant Examiners, he has also been appointed to the national committees; is published in multiple scientific journals; speaks at numerous conferences; mentors adjunct faculty; and runs a clinic for vulnerable breastfeeding mothers that are unable to afford lactation care at no charge.



### MS. JANELL L. LEWIS | CLASS OF 2004

Ms. Lewis received her Bachelor of Arts in Mass Communications with a minor in Spanish from Winston-Salem State University and her Master of Arts in Journalism and Public Affairs from American University in Washington, DC. Currently, she is a fifth grade teacher and media liaison for Lawton Public Schools. Lewis also provides consulting work and most recently worked with KSWO Channel 7 News in Lawton-Fort Sill, Oklahoma, and as Assistant News Director at WTVM News Leader 9/WXTX Fox 54/Bounce TV (Raycom Media) in Georgia.

#### DR. CHERATON F. LOVE | CLASS OF 2005

Dr. Love earned her Bachelor of Science in Molecular Biology from WSSU and her Ph.D. in Microbiology and Immunology from Wake Forest University.

She is currently teaching in her seventh year as a biology instructor and serving in her third year as the dean of First-Year Students and Advising Services at WSSU. Her research interests involve collecting and analyzing data to help determine factors that lead to academic success for first-year students.

She serves on the grant-writing committee and is a current member of Women's Fund, a nonprofit devoted to improving the economic security and well-being of women and girls in Forsyth County.
